



**NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT**  
**this is not a competitive bid/proposal**

The Utah Transit Authority (UTA) Procurement Policy provides that sole source procurements may be used only when the Award of a Contract is infeasible under other source selection methods, and at least one of the following circumstances applies: (a) The required goods or services are of a specialized nature requiring expertise that is only available from a single source; (b) The public exigency or emergency for the required goods or services will not permit a delay resulting from competitive solicitations; (c) After solicitations of a number of sources, competition is determined inadequate.

The UTA Purchasing Department has received a request to make the following sole source procurement:

**Product and/or Service to be purchased:** On-demand TNC multimodal, transportation-as-a-service ridesharing platform and mobile application.

**Contract Duration:** Seventeen (17) Months – April 1, 2025 through August 31, 2026 for Lyft;

**Proposed Sole Source Supplier:** Lyft, Inc

**Estimated Totals:** Lyft, Inc is \$102,000.00

**Sole Source Justification:** There are currently three providers for ReConnect: Uber, Yellow Cab and Lyft. Lyft’s current contract extension ends March 31, 2025, Yellow Cab’s contract extension expires August 31, 2025, and Uber’s contract extension ends December 31, 2025. According to FTA regulation, UTA has to provide customers with options for them to choose to get a taxicab exemption. All the contracts are being extended to expire at the same time to allow for procurement of the ReConnect contract.
